

# North Jersey Yacht Racing Association Regular Meeting February 2, 2012 Monmouth Boat Club, Red Bank, NJ

The meeting was called to order by Commodore Bob Slook at 1945. The roll call of member clubs was called and a quorum was present; the attendees are listed below.

## **Recording Secretary Report- Joe Malik:**

The minutes of the January 5, 2012 meeting were reviewed and approved as corrected. The minutes will be posted on the NJYRA website.

## **Corresponding Secretary Report- Stu van Winkle:**

Stu discussed some issues with maintaining the email list especially with handling the large list of addressees without getting blocked by our email server. The list may have to be partitioned to prevent the mail from being blocked.

## Treasurer Report-Jeff Jacobi:

The current checking assets on hand are \$7,611.77. No checks were written during the past month. The Treasurer still needs to find an interest bearing account for the former Money Market balance of \$7,625.43.

There was no change in the Clubs still outstanding for dues and/or yearbook ads:

•	PYC (2009, 2010 and 2011 dues)	\$240

PYC sent a message stating that they have paid their yearly dues. The Treasurer has no record or evidence of payment. PYC has been asked to provide a copy of the checks so this issue can be resolved. The Commodore and Treasurer will try to contact PYC.

The Treasurer has sent dues and ad notices to all clubs via their NJYRA rep. A NJYRA rep is needed for Raritan YC. The list of commercial advertisers needs to be reviewed. PC Ann Myer and PHRF rep Jim Walsh will be asked to canvas the PHRF community for additional advertisers.

The Treasurer is still updating the list of contacts for sending dues notices. Franz Schneider will check for a LBI contact and Nicky Enthoven will reach out to PYC for a rep.

The Treasurer's Report was approved by the membership.

#### Rear Commodore's Report- Jeff and Bob for Georgi Munger:

The MBC Level I instructor class is already full. Mantoloking YC will hold a double session which will be filled quickly. Jeff will explore if a second class can be held at SSYC.

A discussion of ways to expand the number of Instructor Trainers was held so that additional classes might be held. RC Georgi Munger was asked to review the certification process for instructors and propose a plan to expand the number of trainers.



The RC was also asked to poll clubs to determine interest in Race Management and Judge's seminars/

## **Vice Commodore's Report- Bob for Jim Ballintine:**

A bid was accepted from the Richmond County YC to host the 2012 Portsmouth Handicap Championship on June 30. RCYC is planning on multiple classes (keelboat, centerboard, etc.) and can provide anchorage for overnight stays.

HSC is planning to host the Midget's Championship on July 10. There is a \$15 per car fee at the state park. A goal would be to keep the per boat fee (parking + NJYRA entrance fee) around \$50 or less. NJYRA will assist with Race Officers and Judges if needed.

Significant progress was made in completely the assignment of clubs for NJYRA championships. The process will continue at the next meeting.

## **Commodore's Report-Bob Slook:**

The Commodore has been actively implementing ways to encourage more active attendance by making a Skype conference link available for each meeting and a conference bridge number for an audio. Clubs wishing to take advantage of this method should contact Bob. Bob also encouraged the attendees to "Adopt a Club" and to have everyone call another member to attend. The Commodore encouraged every member club to post their regattas on the website.
